

Terms and Conditions

Registrant give GCC Expressed Permission to send conference information via email and to allow exhibitors to have basic contact information. Information obtained from attendees is never sold to any outside agency.

GCC reserves the right to adjust schedules, dates, location, etc. of the exhibition due to acts of God, acts of terrorism, and/or weather events. Notice of these changes will be advertised and published via website, email notification, and/or other means of announcement.

Admission to the GCC is limited to persons associated with the field of instrumentation and laboratory sciences. Registration is required for admission. Admission is confined to those hours during which the exhibit is scheduled to be open to visitors. An official GCC badge must be worn at the exhibition by attendees at all times and is non-transferrable.

Registrant expressly understands and agrees to be bound by all terms and conditions and rules and regulations contained herein. If any unforeseen event renders it necessary, GCC may amend these terms and conditions and those documents included by reference. Any other changes in the terms and conditions and rules and regulations will be posted to the GCC website.

CANCELLATION: Any registrant who cancels their registration must do so the day before the conference begins by emailing the GCC office at ametcalf@gulfcoastconference.com in order to receive a full refund.

PHOTOGRAPHY AND VIDEOTAPING: All properly badged registrants may take photos of an exhibitor's product(s) or booth(s) provided: Permission has been granted by those whose product and/or display is to be photographed. The booth must have a representative of that company present, whose product and/or display is to be photographed.

EXPULSION: You acknowledge and agree that The Gulf Coast Conference and its affiliates, "Management" reserves the right to prevent you from entering the event or remove you from the Event at its sole discretion for any reason whatsoever including but not limited to your presence or behavior which creates a disruption or hinders the Event or the enjoyment of the Event by other attendees or exhibitors or if you have violated the No Suitcasing Policy or any of the rules related to the event. Neither Gulf Coast Conference nor its affiliates shall be liable for any direct, indirect, special, incidental, or consequential costs, damages or losses arising directly or indirectly from its refusal to allow you to attend or from your removal from the Event or any other aspect related thereto.

NO SUITCASING POLICY: Suitcasing refers to the practice of companies or persons who go to shows as attendees but "work the aisles" from their suitcase (briefcase), soliciting business from other attendees and exhibitors. For the good of the show and the exhibitors supporting the show, the only legitimate place to conduct business during show hours is within a contracted exhibit space on the show floor. Exhibiting companies are encouraged to protect their investment and report any violations to The Gulf Coast Conference. Please note that any attendee who is observed to be soliciting business in the aisles or other public spaces, in another company's booth, or in violation of any portion of the Show Rules and Suitcasing Policy, will be asked to leave immediately.
